With the coming holiday season, many of us will be shopping online. It's a quick and convenient way to shop. Here are some tips to help you shop a bit safer.

- 1. Never click on a link from a spam email to make a purchase.
- Make sure purchase site encrypts your information over the internet. ("https://", instead of http://)
- 3. Use a credit card or an online payment service. This offers better protection should it turn out to be fraudulent.
- 4. Never use a public computer to shop online. Use only a secure connection.
- 5. Use strong passwords. Choose passwords that are difficult to guess, are at least 10 characters long, and use a combination of letters, numbers and symbols.

If you sense something is wrong, it probably is. Watch for warning signs, such as misspellings, requests for personal or confidential information.
